

Release notes for the 2.0.0 version of the EIOPA Solvency II DPM and XBRL taxonomy

Taxonomy aligned with Public Consultation version of Solvency II business requirements

This version falls in the category of early information sharing, containing nonbinding information, and is subject to substantial further changes

I Introduction

This EIOPA Solvency II DPM and XBRL taxonomy package release 2.0.0 is the first version aligned with the outcome of the Public Consultation of Solvency II. **It should be used by the undertakings and solution providers to start preparation of their IT systems for the Solvency II reporting and provide feedback from this implementation**. A new version, 2.0.1, will be published by end of September 2015. It will include fixes to the discovered issues and a second set of validations to be used for report production.

This document describes the content and scope of the package and identifies areas that are potentially subject to change.

VII.1 Taxonomy

VII.2 Availability of files

Taxonomy files are available in the EIOPA webpage only as a compressed <u>package for download</u> and local use.

VII.3 Sample XBRL instance documents

The package contains sample <u>XBRL instance documents</u>, one for each entry point. There are two sets of reports, one contains random data for every table cell, the other has numeric values set to "zeros". Additionally there is a template instance with context and fact for each data point preceded by a comment informing which table and cell it fits.

VIII Validations

List of validations implemented in the taxonomy is <u>available here</u>. Three rules (BV195, BV206 and BC217) are currently implemented as value assertions while in fact they should be expressed as existence assertions. This will be corrected in 2.0.1 release. Six business rules are also marked as not included in XBRL this release. They will be added in the 2.0.1 release. Also the error messages are subject to change (in order to reference variables and display fact values rather than static textual expression).

From business perspective there will be also a STEP2 set of validations included in 2.0.1.

Please mind that there may be additional validations included in the taxonomy to perform additional checks according to the Filing Rules or other technical needs (e.g. check for key column codes used in normalized open tables).
